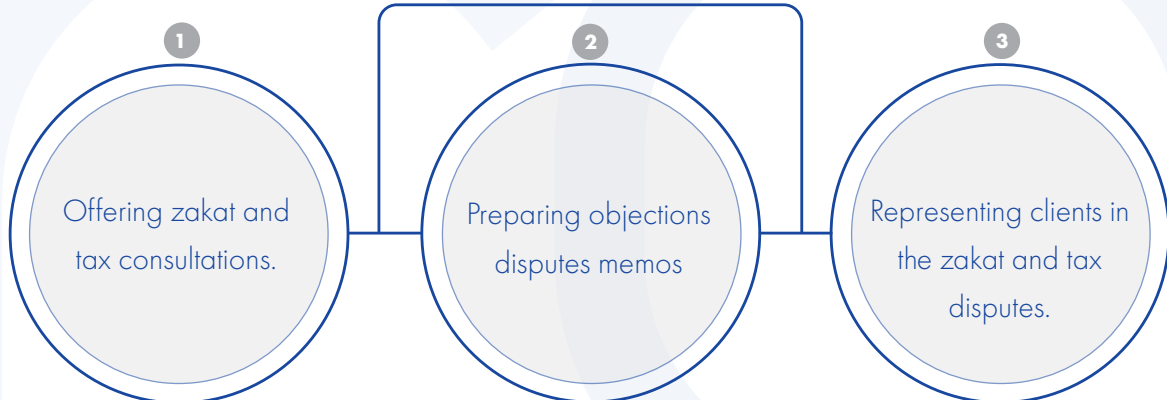


Tax disputes and litigation services:

We also represent our clients in their disputes with the Authority in front of the General Secretariat of Tax Committees.

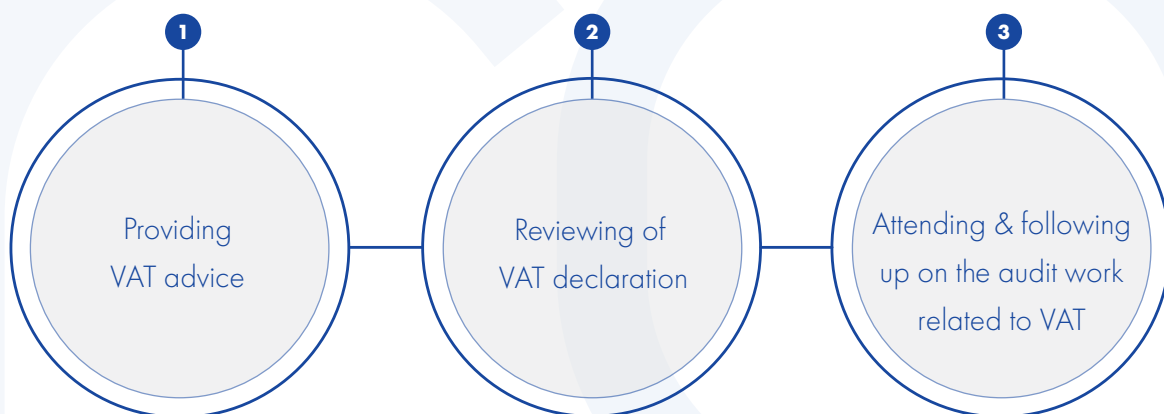
